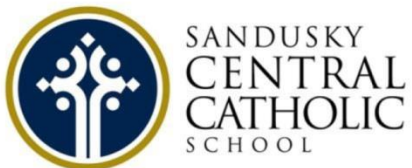

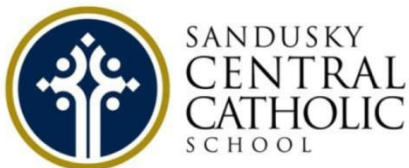

Extended Day Program

Please read and check each item on the left column.

	I understand that I am enrolling my child/children for the current school year. I will be circling the anticipated days and times of attendance.
	I understand that the Extended Care program is open according to the official school calendar of SCCS. I understand that there is no Extended Care on vacation days, inclement weather days, and that there is no afternoon care on early dismissal days.
	I understand that I will be billed bi-weekly. Payments are due in a timely manner; unpaid balances may lead to dismissal from the program. The current rate for the Extended Care program is \$4.00 per hour, per child in attendance. There is a one-hour minimum charge for each Extended Care session that my child attends.
	The program staff will assume responsibility for my child from the time he/she arrives at the program until my child leaves the program according to the written instructions for departure noted on the release form.
	If a medical emergency arises, the program staff will first attempt to contact me. If I cannot be reached, they will contact the additional contact person as provided on the registration form.
	I understand that there is a one-hour minimum charge for each Extended Care session my child attends.
	I understand that if my child will not be attending Extended Care on a regularly scheduled day of attendance, I must notify the director of the absence. If my child is absent from school, the office will notify the director.
	I understand that my child may be dropped off NO EARLIER than 6:00 a.m. and picked up NO LATER than 6:00 p.m. There will be an additional charge of \$15.00 per 15 minute increment for late pick-up.
